Consignment Agreement

Deja Vu Dance Boutique will accept dance costumes, footwear, apparel and accessories for consignment **only if** such items meet the **high standards** of *Deja Vu Dance Boutique*. Accepted items will be consigned for **6 months** from the date of this Agreement ("Contract Period"), unless otherwise agreed upon by the consignor and *Deja vu Dance Boutique*.

Unacceptable Items / Expired Items

If any of my items do not sell within the Contract Period or are unacceptable for resale at *Deja Vu Dance Boutique*, I acknowledge and accept that I will be asked to promptly pick them up, failing which they become the property of *Deja Vu Dance Boutique* and may be sold or donated to an establishment chosen by *Deja Vu Dance Boutique* without notice to me.

I understand that when an item sells, I will receive 50% of the final selling price for such item, excluding all taxes. Alternatively, I may choose to receive an amount equal to 60% of the final selling price, excluding all taxes, as a store credit for future purchases at *Deja Vu Dance Boutique*.

I understand that *Deja Vu Dance Boutique* will make a concerted effort to sell my items for me but that *Deja Vu Dance Boutique* makes no guarantee that any of my items will sell during the Contract Period. Pricing, markdowns and periodic sales are at the sole discretion of *Deja Vu Dance Boutique*. Accounts will be paid out the month following the sale of the item(s).

To protect consignors, *Deja Vu Dance Boutique* reserves the right to ask for photo ID before paying out an account. All information provided to *Deja Vu Dance Boutique* will be bound by the *Deja Vu Dance Boutique* Privacy Policy.

I understand it is my responsibility to collect any money owing to me from *Deja Vu Dance Boutique* for items sold within 6 months from the end of the Contract Period. Accounts left dormant and uncollected after this 6 month period will transfer to and become the property of *Deja Vu Dance Boutique*. *Deja Vu Dance Boutique* is NOT LIABLE for LOSS or DAMAGE to any of consigned articles through FIRE, THEFT, VANDALISM, NATURAL DISASTER, ACCIDENTS, in-store DAMAGE or other perils.

This Agreement replaces all preexisting contracts with *Deja Vu Dance Boutique* relating to the items listed in this Agreement.

By signing this Agreement, I agree to all terms and certify that I own the items brought in for consignment with all rights to sell such items. No other person or entity has any rights to or interest in the consigned goods.

Costume Consignment: Costumes must be clean, odour-free with no rips, tears or stains or requiring any repairs. There must also be no missing rhinestones/embellishments.

Neither the names of costume owners, nor the studios to which the dancers belong, will be released to anyone.

Refund Policy: Items may be returned within 48 hours for a full refund less a 10% restocking fee based on the item's original list price, excluding all taxes. The fee will be waived if merchandise of equal or greater value is purchased at the time of the return.

Return Policy: If you wish to take back any item prior to the end of your Contract Period, you will pay *Deja Vu Dance Boutique* a 25% administration fee, based on the item's original list price, excluding all taxes.
